Privacy Statement

We value your privacy, and we think it's important that you understand what personal information Xen.Al collects from you and other parties, why we collect it how we use it, and any rights you may have as a customer or data subject.

This Privacy Statement explains our information practices, including how we collect, use, and protect the personal data you give us via Xen.Al's Websites.

Personal information collected by Xen.Al:

How We Use your Data:

These interests are supported by the fact that the data is only used for browsing activities related to what is deemed business or professional-related (no content on our website is targeted towards specific individuals or that could be used to infer anything about your personal habits or interests), that we offer simple opt-out options, and that we limit the amount of data that is retained. Xen.Al will only keep your personal information for as long as is necessary to accomplish the goal for which it was acquired when processing it in accordance with any of the legal basis above. On the other hand, Xen.Al shall cease processing your Personal Information upon notification of your withdrawal of consent for such processing if legal is applicable. However, Xen.Al will retain your personal information until the end of the applicable retention period or until the claims in question have been settled if Xen.Al is required by law to retain it for a longer period of time or if Xen.Al needs it to assert or defend against legal claims.

Anybody who supports our company and is contractually obligated to maintain the confidentiality of your personal information and use it solely to deliver services to us is the only third party with whom Xen.Al does not disclose your personal information. Nevertheless, we may divulge Personal Data if we think it is required or suitable under the relevant legislation (i) to abide by any court ruling, statute, or legal procedure, including in response to any request from the government or regulatory bodies, (ii) to uphold or implement our terms of use or any other agreements pertaining to our website, or (iii) to safeguard and defend the rights or property of Xen.Al.
